# **ACCESSIBLE MEETING POLICY**

After 3 years of remote meetings, the Long-Term Care Coordinating Council (LTCCC) will host a hybrid meeting. LTCCC members are required, starting March 1<sup>st</sup>, 2023, to attend meetings in person (unless they request and are approved for a reasonable accommodation) To request an accommodation, contact Valerie Coleman Valerie.j.coleman@sfgov.org. Guests will be able to attend in person or remotely. **The meeting will be held at 1650 Mission St. 5<sup>th</sup> Floor, San Francisco CA 94103.** The office, bathrooms, and conference room are wheelchair accessible and located two blocks from the Van Ness MUNI station, 5 blocks from 16<sup>th</sup> Street BART stations, and on the 14, 14R and 49 bus lines. **American Sign Language** interpreters will be available. Individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [San Francisco Campaign and Governmental Conduct Code sections 2.100 – 2.160] to register and report lobbying activity.
